Captain Cheryl Newman-Tarwater gave a PowerPoint presentation and discussed the document with respect to the 2014 Crime Statistics, Notable 2014 Arrests, Clergy Compliance & Audit, Social Media Monitoring, Safety and Security-Educational Site Survey and Information Sharing (ESSIS), and Community Oriented Policing Surveys.
