• Mr. Cornner gave an overview of timeline as it relates to FTES submission (July) as well as the dates MIS data is due to the state (Sept) Financial aid data is submitted Nov. 1. Transfer data will be available in January. These MIS data files are now going to be used for the Student Centered Funding Model.

- In the process of updating enrollments reports for the purpose of better indicators for non-credit.
- Fall 2018 enrollment report day 22 was distributed: Credit Enrollment comparison indicates that we are 3 % down in enrollment, however it's expected to improve.

- Preliminary Fall 2019 FON scheduled was distributed, showing the Fall 2019 FON advanced number to be 1,731 however this number was calculated on a FTES base of 102,667.

- The State has allocated approx. \$4.5m in full time faculty funding, of which the District will have to hire 57 faculty members in order to receive this money.
- The preliminary number of faculty hires to be made to meet our Fall 2019 FON is 75 (which includes the 57 needed to maintain the extra FON funding).

The District has been regularly adjusting scenarios to meet changes in the state model and as new data have become available. The current status of the metrics are as follows:

- The results indicate 99,996 FTES reported, down from the 2016-2017 actuals and down more than 2,000 FTES from P2 submissions used by the state for their scenarios.
