I have been working with Microsoft as one of our partners since 2017. As a result of this important relationship, on 9/29/22 I received an email from Microsoft indicating that our institution has been identified as a good candidate for the Microsoft Learn for Educators program.

Since that time, I have been trying to get the Business Terms (PR 10061589) to be signed by our institution, so we can move forward with the program. I learned that the Business Terms must be approved by the Board of Trustees.

Based on the information provided by the district, I learned that the agreement was on the board's agenda for March to be approved. Based on the information provided, I communicated to Microsoft that the terms is on the board's agenda for March. In April when I inquired about the status of the Business Term, I learned that the Microsoft Business Terms was pulled from the Board of Trustees agenda by IT. Why did IT pull it out? How long will IT take to review the terms? What is the process for the MOU to be approved by the board? And why does it take long time? Why was there no communication to our campus that the item was pulled by IT?

## **LACCD ENGLISH OUTCOMES: Transfer-Level Course Success Rates**

**Statewide:** Course success rates of transfer-level English courses declined since AB 705 implementation (71% to 65%). The total number of students completing transfer-level English in one term declined in 2020-21. Equity gaps for students of color.

**LACCD colleges:** Six out of nine were below state average (Southwest, Mission, East, City, Trade & Harbor)



## **LACCD MATH OUTCOMES Transfer-Level Course Success Rates**

**Statewide:** Course success rates of transfer-level Math courses have also declined since AB 705 implementation. Equity gaps for students of color.

LACCD colleges: Seven out of nine below state average (Mission, Trade, West, City, Harbor, Valley & East)
