Budget Cuts and Solutions

Mr. John Clerx indicated that the level of funding for the upcoming fiscal year is expected to be the same as the current fiscal year. He reported on the possible impending increase in the enrollment fee and the possible elimination of the California Community Colleges Board of Governors (BOG) fee waiver. He urged the ASO/ASU Presidents to write letters to their local legislators opposing these actions.

He further stated that the Board Rule regarding the Student Trustee term limit was suspended in order to allow the Board to appoint Rodney D. Robinson as Interim Student Trustee.
