She indicated that at this meeting, she would raise the issue of student governments spending more than the amount they are budgeted for in the current year and the issue of ensuring that all of the ASO/ASU Advisors know how to utilize their Information Technology department to send out mass emails to the student body.

#### Campus Relations with Local Public High Schools

Interim Student Trustee Batham indicated that this discussion will focus on: (1) connecting with the local high schools to encourage students to attend college in order to further their education; (2) connecting high school students with the LACCD colleges; and (3) bridging a relationship to get the students involved in the college community.

The Committee members discussed what their respective colleges are doing to recruit high school students.

Interim Student Trustee Batham requested that the ASO/ASU Presidents get in touch with their campus recruiters and inquire as to how the ASO/ASU can become involved in bridging the relationship with the high schools. He requested that the ASO/ASU Presidents provide a report at the SAC meeting of May 18, 2012 regarding the status of this effort.

Ms. Kimble indicated that she has been working with the *Alliance for College-Ready Public Schools* with respect to its effort to test pilot a senior day on their campuses. On this day, the Alliance will present information regarding how to enroll at an LACCD college.
