District Office Report

Ms. Bobbi Kimble reported regarding SB 440 (Padilla) – Public Postsecondary Education: Student Transfer Achievement Reform Act as it relates to the acceptance of Transfer Model Curricula (TMC) AA and AS degrees by the California State University (CSU) system. A link to the bill is as follows:

Ms. Kimble reported that there are currently 16 statewide degrees that have been approved by both the community colleges and the CSU colleges as being inter-transferable. She indicated that of these 16 degrees, all colleges were required by law to have had two of them online by the fall of 2012.

Ms. Kimble reported that both LAHC and LAPC were offering gun safety classes out of their Community Services programs, which are required by law to be fully self-supporting. She indicated that the Board of Trustees had not been aware of these Community Services offerings and indicated that she is preparing an agenda item for the Institutional Effectiveness Committee meeting of August 21, 2013 regarding this issue.

STUDENT INFORMATION SYSTEM (SIS) MODERNIZATION PROJECT MONTHLY UPDATE REPORT

Ms. Betsy Regalado distributed a document entitled "SIS Modernization Project June 2013 – Recommended Deployment Plan."

The participants introduced themselves to Ms. Regalado.

Ms. Regalado and Mr. Christopher Nersisyan discussed the document with respect to the Implementation Team, What is the Student Information System?, Why do we need to change our legacy system?, How will the new SIS project be funded?, software solution – PeopleSoft Campus Solutions, implementation solution – Ciber, guiding principles, fit gap analysis sessions, notes from the fit gap analysis sessions, deployment options, initial system configuration timeline, the phased module development, advantages of the phased module approach, training, student involvement, communication plan, retirement of the current SIS system (DEC), and "Failure is not an option."

A question and answer session was conducted regarding the SIS Modernization Project.

Proposed Changes to Board Rule 8603 – Limitations on Enrollment

Ms. Kimble distributed a document entitled "Second Version of Proposed Changes to BR 8603 – Limitations on Enrollment." She indicated that the Vice Presidents of Academic Affairs is recommending that three additional priority categories for students be included. These categories would be CalWORKs students, student athletes, and international students. She stated that before this recommendation could be submitted, the District was notified by the state that CalWORKs is now going to be a priority category. Therefore, this category is no longer subject to discussion. She indicated that the proposed amendment includes the addition of language regarding the loss of enrollment priority appeals

There was discussion regarding whether or not student athletes and international students should be included in the priority enrollment categories.

Ms. Kimble indicated that a brief SAC meeting could be held on September 13, 2013 at LATTC in order to come to a final decision regarding the proposed changes to Board Rule 8603.
