Finalize the District's 2016-17 State Legislative Priorities

Dr. Robert B. Miller, Vice Chancellor of Finance and Resource Development, provided a document entitled "Proposed 2016/17 State Legislative Priorities, which is a recap of the 2016/17 State Legislative Priorities developed at the Committee meeting held on October 12, 2016. He also provided a handout from the McCallum Group, Inc. with the 2017-2018 Budget Priorities for various Districts and the LACCD. He deferred to Dr. Francisco Rodriguez, Chancellor.

Chancellor Rodriguez discussed the process and timeline to finalize the District's 2016-17 State Legislative Priorities, which is expected to be finalized by January 2017.

Chancellor Rodriguez discussed the document entitled "2017-2018 Budget Priorities" that was presented on behalf of various community college districts and the LACCD with respect to Growth/Restoration, COLA, Base Allocation Increase, Full-Time Faculty, Community College Promise, Mental Health, Mandate, and Part-Time Faculty Office Hours.

Chancellor Rodriguez discussed the document entitled "Proposed 2016/17 State Legislative Priorities, LACCD Board Legislative & Public Affairs Committee, October 12, 2016" and vetted the Committee on the draft priorities for the State and Legislative budget items in terms of funding and priority.

A question and answer session was conducted regarding the presentation.

Chancellor Rodriguez stated that the Committee's direction for the District's 2016-17 State Legislative Priorities are noted and will be presented at the December 7, 2016 Legislative & Public Affairs Committee for an ultimate review and in January the list of priorities will be finalized.
