# COVID-19 VACCINATIONS

- L.A. County Department of Public Health opened Education tier for appointments effective March 1, 2021—almost exactly one year since pandemic emergency declared in March 2020
- Public Health first focused on K-12, but now helping Institutes of Higher Education, including LACCD:
  - LACCD personnel 65 and older to get appointments ASAP
  - Additional vaccine allocations for Higher Ed in L.A. County in weeks ahead –more details to come
- Shortages in supplies and appointments expected to be cleared up in March as Blue Shield assumes State oversight and additional supplies from Johnson & Johnson arrive
