


#### Native Language Teaching as an Opportunity

#### Students Who Speak More Than One Language at Home









### **More Survey Results - Spring 2022**

#### Methodology


- Online survey offered in English and Spanish conducted October 7-19, 2022; total of 1,500 completes.
  - 1,250 English-dominant or English/bilingual sourced from an opt-in panel
  - 250 Spanish-dominant sourced from proprietary mobile phone database
- Required to reside in Los Angeles County and be aged 18+ years.
- The characteristics of respondents did not exactly match the composition of residents in Los Angeles County based on age, gender, race/ethnicity, household size, and household income.
  - Results have been weighted using generally accepted statistical methods to approximates the characteristics of County residents per the U.S. Census Bureau's American Community Survey 2020.


## Interested in Taking Classes in Language Other than English



- ❖ 44% of current community college or vocational school students surveyed agree language is a barrier to successfully entering or finishing school.
- Classes taught in Spanish would serve the greatest number of people interested in such classes.
- Subjects related to business and general education were of greatest interest.
- The LA City (East Hollywood), East LA (Monterey Park) and West LA (Culver City) campuses were the locations most often selected by residents interested in taking classes in- language classes.



#### **Would Support In-Language Classes If...**




Support for in-language classes is contingent upon no new taxes and no reduction in the current number of courses taught in English.

LA County residents who agree community colleges & vocational schools:


- Should be accessible to all residents regardless of language skills = 87%
- Are essential to producing a skilled workforce = 88%
- Help people who speak
   English as a second
   language to get better jobs =
   87%



- Two-fifths (39%) of those interested in taking in-language classes want the classes to learn business, finance and real estate.
- The second most popular choice is general education.







#### STUDY LIMITATIONS

- Survey was available only in English and Spanish languages.
- Includes only Los Angeles County residents who are English, English/bilingual and Spanishdominant speakers; persons dominant in other languages (e.g. Mandarin, Hindi) are not represented.
- Nonetheless Survey results are in-line the U.S. Census Bureau's American Community Survey 2020 which shows 56% of Los Angeles County residents speak a language other than English in the home.
- This survey finds 57% of residents speak a language other than English in the home.



## Legislative Advocacy





- "English shall be the basic language of instruction in all schools."
- "It is the policy of the state to ensure the mastery of English by all pupils in the schools, provided that bilingual instruction may be offered in those situations when such instruction is educationally advantageous to the pupils. Bilingual instruction is authorized to the extent that it does not interfere with the systematic, sequential, and regular instruction of all pupils in the English language."

#### **Legal Framework For Non-English Instruction**



The Education Code defines bilingual education as "a system of instruction which builds upon the language skills of a pupil whose primary language is neither English nor derived from English."



## What AB 1096 (Fong) Does



#### THE PEOPLE OF THE STATE OF CALIFORNIA DO ENACT AS FOLLOWS:

#### **SECTION 1.**

Section 30 of the Education Code is amended to read:

**30.** 

- (a) English shall be the basic language of instruction in all schools.
- (b) The governing board of a school district, or community college district, and any private school may determine when and under what circumstances instruction may be given bilingually.
- (c) It is the policy of the state to ensure the mastery of English by all pupils in the schools, provided that bilingual instruction may be offered in those situations when that instruction is educationally advantageous to the pupils. Bilingual instruction is authorized to the extent that it does not interfere with the systematic, sequential, and regular instruction of all pupils in the English language.
- (d) Pupils who are proficient in English and who, by successful completion of advanced courses in a world language or by other means, have become fluent in that language may be instructed in classes conducted in that world language.
- (e) (1) A community college may offer courses taught in languages other than English. Students may enroll in these courses without being required to concurrently enroll in an English as a Second Language (ESL) course.
- (2) Nothing in this section shall be construed to prohibit a community college student from enrolling in an ESL course, or preclude a community college from complying with the requirements set forth in subdivision (a) of Section 78221.5.

# AB 1096 (Fong) Educational Instruction: Native Language of Instruction





- Introduced February 15, 2023
- Passed the Senate September
   11, 2023 Ayes 39. Noes 0
- Passed the Assembly September
   12, 2023, Ayes 79. Noes 0
- Approved and Signed by Governor Gavin Newsom on October 8, 2023
- Section 30 of the Education Code Chapter 559, Statutes of 2023

- Pilot Program Started in Winter 2023 (15 noncredit classes)
- Class offerings continued and expanded:

Winter 2024	11	203
Spring 2024	57	1,363
Fall 2024	85	2,194

Total	412	10,105

• Since Winter 2023: 412 classes and 10,105 enrollments
